### The Roop Freshet

As reported in the Carroll County Times Free Press; "April 23, 1883, a flying report came to Roopville at 3 o'clock p.m. that the family of B. Josephus (Ceph) Roop, his brother, Thomas M. Roop were all drowned in what would be the most horrific natural disasters to occur in Heard County.

Merrell's Mill was a small, rural community in the western part of Heard County next to the Hillabahatchee Creek. Robert Merrell, Sr. had established a prosperous family business with a large plantation, corn and wheat mills, gin, blacksmith's shop and store.

Mr. B. Josephus (Ceph) Roop, married Georgia Merrell and lived at Merrell's Mill with their three young children; Beulah, Homer and Ella. Ceph's father was Martin Roop, the founder of Roopville Georgia. Ceph and his brother Thomas M. Roop were employed by Mr. Merrell to help manage the Merrell family enterprise at Merrell's Mill. Thomas M. Roop and his family lived in Roopville, he would stay with his brother during the week and go home on the weekends to be with his family.


Thomas M. normally traveled on Monday morning, but this fateful trip would begin on Sunday afternoon.

Sunday began like any other day, calm and relaxing. Late in the afternoon around the supper table, Mrs. Roop remarked as to how dark it was getting outside. Great clouds were gathering as the family enjoyed social time together, oblivious to the fate that awaited them.

Rain and hail soon began to fall. Lightning was so bright and long lasting that it was possible to read the headlines of the newspaper.

While the family retired for the night, the rain fell furiously outside. The water came rushing down from every hilltop, accumulating in every ravine. "Branches became creeks and creeks became rivers."

About 3:25 a.m. Pricilla Ridley waked Mr. Ceph Roop with loud knocking at his upstairs bedroom door. "There's water on my floor, Mr. Roop, there's water on my floor." Mr. Roop dismissed it thinking it was connected to an earlier homesickness episode. Pricilla Ridley was a 12 year old black child that was hired to help with the children. When her dad dropped her off in the afternoon she cried saying she wanted to go home. Could it have been a premonition or just homesickness.



In the meantime, the water level was rising very rapidly all over the first floor of the house. Mr. Thomas M. Roop asked his brother what he should do and he said "Save yourself if you can".

Pandemonium ensued in what would only take ten minutes. Mrs. Roop was calling out to her father, Mr. Robert Merrell who lived a little higher up from the mill. He tried to reach her but could not as his canoe and the bridge across the road had been washed away,

Mr. Ceph Roop begged his wife to leave their abode immediately but she refused, expressing her determination to remain with their children. "The house washed from its pillars down-stream and drifted above water for some 500 yards until it hit a cliff and busted asunder".

Mr. Ceph Roop, who had been securing himself in the second floor window of the house, was thrown into the torrent as the house washed from its foundation. He swam after the house and became buried under the timbers when it crashed into the bluff. The screams of the victims could be heard distinctly back at the mill by those safely ashore. Mrs. Roop and the children were drowned in the crash.

Thomas M. Roop made it to the porch of the store only to be washed away later. He would be found a few days later.

Mr. Ceph Roop surfaced miraculously and drifted amidst the broken timbers and logs and swift downstream current. He was finally able to catch hold of a limb of a tree and pull himself into the fork of the upper limbs, three-fourths of a mile away from the mill. He was cold alone, in the dark, shocked emotionally and physically, and worried about his family.

The next day, search parties gathered to look for survivors and victims. Fortunately, all the bodies of the drowned were found and laid to rest.

So violent was the rush of waters, that even fishes, frogs, and turtles were found dead. The Roop's and Merrell's thought they had built their houses above the danger of high water. But the cloud burst that caused the creek to rise 25 feet above the low level mark could not be predicted.

Today, all signs of the mill and home sites are gone. A steep climb of 500 yards or so from the mill site will be the only artifact, the cemetery containing the graves of Mrs. Roop and her three children.

SERGEANT DAMON MILLER Carrollton, Ga.

Sergeant Miller enterod service
June 10, 1917, as a private.
Was attached to Motor Truck
Company No. 340, Camp Gordon, Atlanta, Ga., with which unit he served with rank of
Sergeant. Was given sick-leave to visit his home at Carrollton, Ga., where he died of tuberculosis, December 24th, 1918.



Bowdon, Ga.

Private Robinson entered service April 27th, 1918, at Camp Lee, Va., where he received his preliminary training. Embarked for over-sea service with Company "M," 11th Infantry (division not known). Private Robinson was in the front line trenches at Meuse, France, when he was killed in action, October 3rd, 1918.

Private Rooks entered service
July 15th, 1918. Was attached
to a Machine Gun Company
with the 9th Infantry, 1st Battalion. Embarked for over-sea
service in August, 1918. Was
killed by an enemy bullet while
caring for a wounded soldier on
the battlefield, November 3rd,
1918.



Villa Rica, Ga.

Private Smith was attached to
the September Automatic Replacement Draft, Coast Artillery Corps, Ft. Screven, Ga.
Embarked for over-sea service
in September, 1918. Was
drowned in the sinking of the
ill-fated transport "Otranto,"
off the Scottish Coast, October
6th, 1918.



Bowdon, Ga.

From all information obtainable, Sergeant Payne entered service in 1912. At the time of his death he was attached to Company "B," 19th Infantry (division not known). Died of tuberculosis February 22nd, 1918, at Ft. Bayard, New Mexico.
