# Dr. LaShun Burr Danley to Speak to May 16th Meeting

#### Surveyers and Indians Encounter in 1827 in Carroll County

The party of Indians obtained written orders from Little Prince, head chief of the Creek Nation, demanding that the surveyors desist from stretching a chain west of Bright's Line. A few days later they broke up Kendrick's operation and seized his compass.<sup>47</sup> Little Prince also dispatched a letter to Troup protesting the actions of the surveyors, but Troup ignored the letter.<sup>48</sup> On January 7, 1827, seven or eight defiant Indians confronted Elijah Byne and his men, who were running the lines of the 13th District of Carroll County. They presented Byne with Little Prince's order and, when Byne refused to discontinue his work, took his compass. At the same time they disdainfully brandished before him the compass they had seized from Kendrick.<sup>49</sup>

On January 21, 1827, James A. Rogers and his men had just marked a pine station thirty-one chains east of the southwest corner of Land Lot 167 of the 9th District of Carroll County when they collided with an angry party of Creek Indians.<sup>30</sup> Rogers sent the following urgent message to Governor Troup explaining the matter:

January 23, 1827 his Exelency Geo M Troup

Sir Inclosed you will find a copy of an Instrument of writing that was handed to me by A parcel of Indians on the 21st Inst and after I red the letter they demanded of me my compass which I had to Surrender to them but after a few minutes they agreed to give me back my compas and would come with me over the New Treaty line which they did and Threatened me very Sovere if I Should be caught over Brights line again a Surveying. I have come on to McIntoshes old place and have Stopt my hands until I hear from you[.] if you Intend to give me assistance I hope you will take the Earliest measure to get it to me as provision is scarce and my hands uneasy to go home. as to the Number of Min it will take to guard me I am unable to Say[.] my Situation is

this[.] there is three Settlements of Indians in my district that have in them about tin min and in two miles on the Alabama Side there is a Large Town that I am told have from forty to fifty wariors in it which is to be placed on the New Treaty line as Spies and [to] prevent the Land from being surveyed & as for further Information I will refer you to Maj<sup>r</sup> Parramore the bearur of this express and who was with me whin the Indians Stopt me

Gentlemen We the undersigned Chiefs and head men of the Creek Nation having learnt with great regrett that you are engaged in Surveying the lands West of the line of the late Treaty and which was not Ceded by that Treaty we have again to request and demand of you in the Most friendly terms that you will desist from Stretching a Chain over any of our lands not Ceded by the Said Treaty[.] we flattered our Selves and we had a right to believe the Stipulation of that Treaty would have been friendly observ<sup>4</sup> by all parties concerned and that our former Differences with our Neghbours the Georgians would have been finally settl<sup>4</sup> and that we would in future live in the Strictest friendship in all our Intercourse[.] We are determined on our part not to do an act that can be Calculated to give offence but we [have] right[s] and we hope they will be respected

We are your friends his Little X Prince mark

### THIS MEMORIAL DAY CARROLL COUNTY WILL REMEMBER AMERICA"S ENTRY INTO WORLD WAR I



This photograph from the Carroll County Historical Society Archives shows students from the Carrollton Public Schools helping lend their support for the god old red, white & blue and the U.S. involvement in World War I during the "2nd Liberty Loan Day", Oct 24, 1917. The United State officially entered "The Great War" in Europe on April 6, 1917. Notice the people in this photo: besides the many school students in their folded newspaper hats, there were soldiers & sailors, young nurses in uniform, a young drummer boy, Uncle Sam and people in patriotic straw hats and local citizens all dressed in their Victorian finery. All Carroll County citizens taking time out of their lives to show their patriotic pride and rise some needed funds to support the American war effort. "

#### One of the banner reads "If You Can't Go Across, COME ACROSS"

This photo was taken on NE Quadrant #1 of Adamson Sq.in Carrollton, most likely by J.G. Buyer's who first had a studio on the second floor of two-story building on the far left which was later known as the Boykin Law Firm Bldg. and now home to Southwire Offices. Buyer's later moved to the Beall Bldg. (now Gallery Row Coffee) as the first of 4 photographers on the second floor of that building. The Building from left to right. (Rome to Newnan Streets): John Baskin Clothing, a restaurant, Johnsons Drugstore, a print shop with The Gainesboro Telephone upstairs, ? Tyus (formerly U.S. Post Office), Moore & Cleins, G.J. Buyers, and Photography Studio upstairs.

### Carroll County D.A.V. Chapter No. 19 BBQ and Club House Dedication in 1931



On Nov. 11, 1931, the Milton Edison Chapter No. 19, Disabled American Veterans officially dedicated its new clubhouse with a grand BBQ for its members. In 1931 was 10 years removed from being involved in World War I and 10 prior to being reentering war in Europe again in WWII. However the community of Carroll County was no less appreciative of the part its disabled veterans had played in helping to make American the great world power it had become. By the fall of 1931 the disabled veterans of Carroll County and Carrollton had a brand new clubhouse to call home. A place like this could not have been built by a small band of disabled veterans alone. It certainly took a nation of dreamers and a community volunteers who believed that the brave and courageous veterans in its midst deserve a good place to meet, gather, so-cialize and conduct business, so vital to those who had returned home to America from fighting in Europe. World War I was like no other war that had ever been fought up until that time. There was a new kind od enemy, new weapons of mass destruction and a totally new way of fighting that emerged from what was known then simply as "The Great War.

**On Saturday, May 27, 2017 at 10:30 a.m. the Carroll County Veterans Park will host a speech by Gen. John J. Pershing**, who led the American Expansionary Force or AEF during its two years of fighting in Europe. Gen. Pershing comes to us from Pennsylvania and will be leaving us to head to Washington DC to participate in National Memorial Day Parade on Monday, May 29<sup>th</sup>, 2017, which will be remembering American entry into World War I.
